CRITERIA AND FORM OF ASSESSMENT	The form of the final semester control in this discipline is an oral exam. The exam ticket contains 3 questions (3 theoretical). The maximum number of points for studying the course - 100, including: - the total number of points for the current assessment on relevant topics (maximum 40 points) (Module 1); - the total number of points for modular tests (maximum 60 points) (Module 2). The minimum required for successful completion of the bite is 60 points. If the current semester grade is at least 75 points, then with the consent of the student, it can be credited as a final grade in the discipline. Otherwise, or if you want to increase the rating, the student takes the exam. In this case, the points obtained as a result of modular tests are canceled. Examination grade is determined in points (from 0 to 60) based on the results of examination tasks. In this case, the final semester grade is defined as the sum of the current semester and exam grades in points according to the grading scale.				
COURSE ETHICS	Assessment in seminars is based on the student's ability to analyze and impart knowledge, presentations are given in independent work, references to materials and resources are required, and each student is personally responsible for academic integrity. Missed lectures are not practiced, seminars can be completed only if there are good evidence of the absence of the student. Deadline for passing missed seminars (subject to good evidence) before the day of the exam. The maximum number of passes without good evidence - 2.				
GOAL AND OBJECTIVES OF THE COURSE	Course description : The orientation of Ukraine's foreign economic policy on the integration of the economy into world economic relations and ensuring economic sovereignty in the process of foreign economic activity requires (as one of the important components of effective activity in world markets) the presence of highly qualified specialists in foreign trade. at the enterprise level. The aim of the course is to reveal the basic economic and organizational principles according to which foreign trade becomes profitable for both the state and the enterprise. The main objectives of the course are :				

- assimilation by students of knowledge of organizational and commercial principles, forms and methods of international trade, the mechanism of its regulation in accordance with generally accepted norms and practices of their application;

- formation of students' objective approach to understanding, role, place and importance of foreign trade in the economic mechanism;

- mastering by students the ability to analyze foreign trade operations to determine the rationality of the benefits arising from the development of industrial, trade, economic and scientific and technical relations with foreign partners.

- In the process of studying the subject students will be competent in the following issues:

- be able to reveal the potential importance of international trade as an integral part of international economic relations, to analyze current trends in the world market of goods and services;

- be able to analyze the dynamics of volumes, structural changes in the external activities of the state, track current and future trends in foreign trade of Ukraine and their compliance with economic interests of the state, conceptual approaches to strengthening economic security in foreign trade;

- be able to assess the situation in world commodity markets, compliance with the conditions of trade and opportunities to improve them through ways of geographical and commodity diversification of Ukrainian exports.

- be able to calculate the volume, effectiveness, structure, intensity of international trade;

- be able to reveal the conceptual definition of the effectiveness of foreign trade at the macro and micro levels, to analyze the dynamics of development and comparison in international trade; take into account projected changes in commodity markets and due to the policy of resource conservation (export-expanding growth) and import substitution (importsubstituting growth).

- be able to reveal the essence of forms of international trade on the specifics of its regulation, in relation to the subject of trade, the interaction of entities;

- be able to systematize the methods of international trade, analyze trade and intermediary operations, understand the peculiarities of the functioning of organized international commodity markets, pricing in world trade and the formation and establishment of foreign trade prices in foreign economic contracts.

- be able to understand the types of trade policy, the system of regulation of international trade through the use of flexible combinations of economic and administrative methods;

- be able to analyze the activities of trade organizations of supranational and commodity direction in the regulation of international trade (GATT / WTO, GATS, UNCTAD, UNISTRAL, ICC, OPEC, APEF, CIPEC, ECSC, ABC, MPTF, SKEB, etc.), legal support for Ukraine's participation in the WTO and GZFT + and the EU.
