<b>Features of the program</b>	The training is aimed at the formation of theoretical knowledge and practical skills of analysis and organization of the activities of the subjects of international economic relations with increased attention to the subjects of international business. Due to the interdisciplinary interaction of educational components in the educational program "International Business" a wide range of training is achieved. The program includes in-depth study of foreign languages, focuses on the demands of stakeholders, provides for translation and production practices on the basis of enterprises-entities of international business (Agreement №84-06Ф / 62U dated 12.03.2013 with General Logistics Consult LLC, Memorandum № 25U dated 25.02.2020 from Tigres-Lux LLC, etc.), which provides an opportunity to gain practical skills and additional competitive advantages in the labor market.

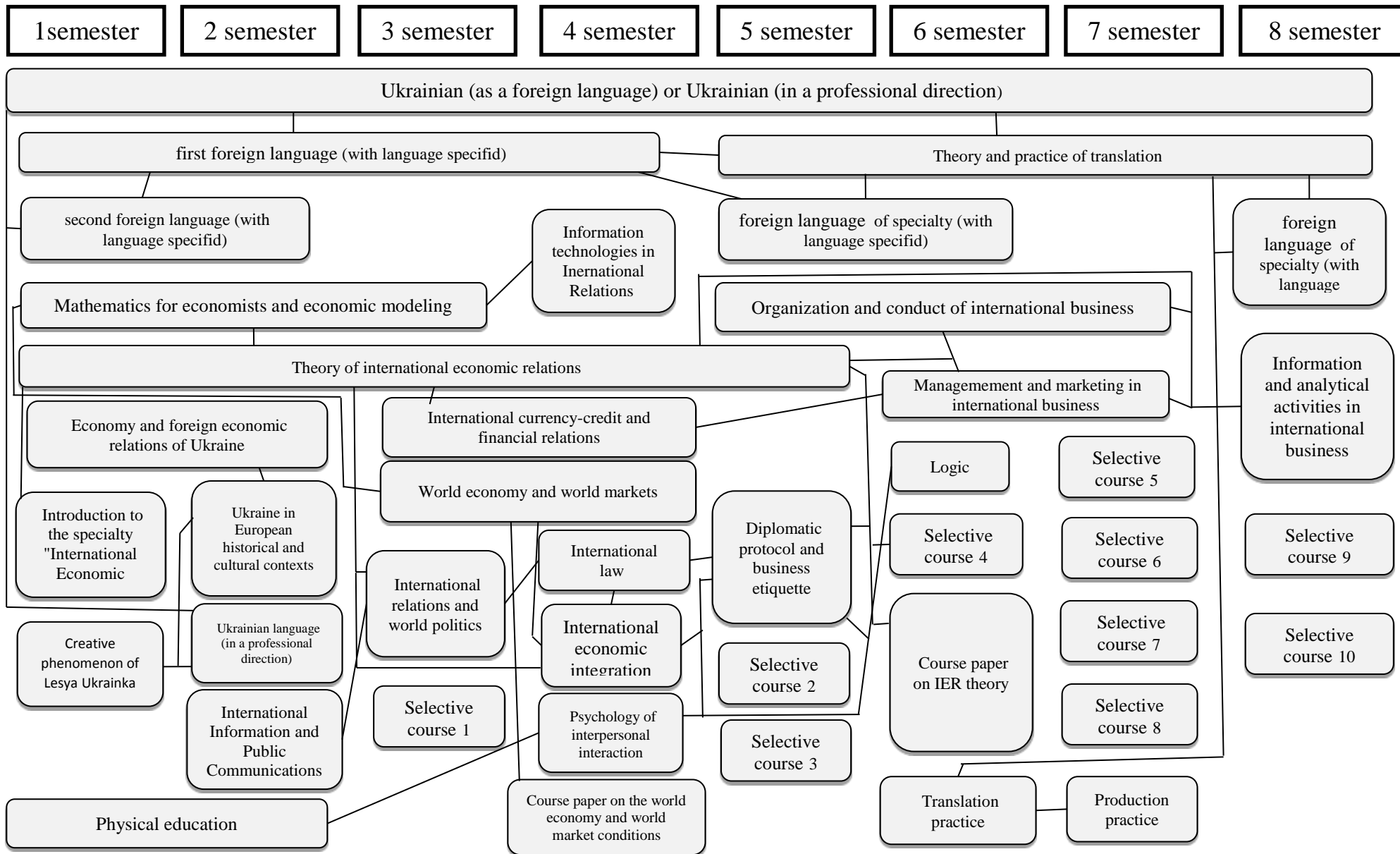

### **3. Forms of attestation of higher education applicants**

Certification of applicants for specialty 292 “International Economic Relations” of the educational program “international business” is carried out in the form of public defense (demonstration) of the qualification work.

Requirements for qualification work: qualification work involves independent solution of a complex task or complex problem in the field of international economic relations, accompanied by research and/or application of innovative approaches and characterized by uncertainty of conditions and requirements. It must meet the requirements of the regulations on final qualification works of 02.10.2017 and Regulations on the system of prevention and detection of academic plagiarism in the scientific research activities of applicants for higher education and scientific pedagogical workers of the Lesya Ukrainka Eastern European National University dated 10.02.2017. Qualification work must be placed in the closed Electronic Fund of qualification works of the University. It can be voluntarily posted by the applicant author in an electronic repository of the Lesya Ukrainka Eastern European National University for open access.

Based on the results of certification, a standard document is issued on awarding the applicant a bachelor's degree with an educational qualification – Bachelor of international economic relations and a professional qualification – a specialist in international business and translation (with language specified).

## РЕЦЕНЗІЯ

Волинського національного університету імені Лесі Українки

Рецензована освітньо-професійна програма (ОПП) розроблена кафедрою міжнародних економічних відносин та управління проектами Волинського національного університету (ВНУ) імені Лесі Українки являє собою комплекс загальної інформації щодо профілю, мети та основних характеристик ОПП, придатності випускників до працевлаштування та подальшого навчання, викладання та оцінювання, програмних загальних і фахових компетентностей та результатів навчання, ресурсного забезпечення реалізації ОПП, переліку освітніх компонентів, матриці відповідності програмних компетенцій компонентам освітньої програми та забезпечення програмних результатів навчання відповідними компонентами освітньої програми за даним напрямом підготовки.

ОПП спрямована на вивчення традиційних форм міжнародних економічних відносин, методології їх регулювання, механізмів взаємодії суб'єктів міжнародного бізнесу, управлінських, математичних, аналітичних, маркетингових основ міжнародного бізнесу, іноземних мов і т.п. Особливу актуальність для підвищення потенціалу розвитку економіки нашої країни зумовлюють фахівці, які здатні ефективно діяти в умовах міжнародної конкуренції, володіти основними принципами і нормами міжнародного бізнесу, тактикою діяльності і методами просування на світові ринки конкурентоспроможної продукції.
