#### III. DESCRIPTION OF THE ACADEMIC COMPONENT

#### 1. A Course abstract

The educational discipline of the cycle of professional training «Foreign policy of countries and regions» provides students with the nature, dynamics, and principles of foreign policy implementation; understanding the essence of globalization processes and their impact on international relations; the ability to analyze and forecast foreign policy in various contexts, including political, security, legal, economic, social, cultural and informational; in-depth knowledge of the nature and sources of the state's foreign policy, the evolution of approaches to the formation and implementation of foreign policy, the principles of the organization of the foreign policy system and the functioning of foreign policy institutions; the ability to conduct applied analytical studies of foreign policy problems, professionally prepare analytical materials and references; ability to organize and conduct international meetings and negotiations, work within the framework of international conferences, organizations, other forms of practical international cooperation, work with diplomatic and international documents; the ability to develop approaches to solving problems and tasks in the field of foreign policy, international and national security, foreign policy (in particular, international and domestic conflicts).

#### 2. Goal and tasks of the academic component

The goal of the course «Foreign Policy of Countries and Regions» is to acquaint students with the main vectors and features of the bilateral and interstate relations development of the countries of the region, to develop skills in analyzing their foreign policy course and the features of the foreign policy contacts development in the international arena. The educational discipline is a set of knowledge and skills that form the international profile of a specialist in the field of international relations.

Course tasks: studying the features of formation, development, and main trends in the foreign policy of the countries of North America, Europe, Asia, Latin America, Africa, Australia, and Oceania. The discipline is based on student's knowledge from the courses «Introduction to the profession», «International relations and world politics», «Political geography of countries and regions».

#### IV. EVALUATION POLICY

#### V. FINAL CONTROL

The form of final control is an exam, the passing of which is mandatory. It is conducted orally. The exam ticket includes 3 questions: one from each content module (each semester). On the exam, the student receives from 0 to 60 points. The total number of points for the course is 100. It is formed as the sum of the points for the current assessment (40 points) and the final assessment (60 points).
