III. DESCRIPTION OF THE ACADEMIC COMPONENT

1. A Course abstract.

The academic component *International and regional conflicts* is included in the cycle of professional training disciplines. In the course of studying the specified discipline, students gain knowledge about modern international and regional conflicts on the planet, their main content, causes and consequences, development trends and possible solutions, as well as their impact on modern international relations, etc.

2. Goal and tasks of the academic component.

The goal of the course is to study the nature and the origin of modern international and regional conflicts, the main forms of their manifestation, trends and specifics of development at the current stage. It is aimed at developing skills in practical analysis of the assessment of the impact of international conflicts on the modern international system and world politics both globally and regionally levels

3. The main tasks are:

- formation of students' comprehensive knowledge about the most important conditions, causes, factors and reasons for the emergence of international and regional conflicts;
- implementation of understanding of the main types, forms, content and manifestations of modern international and regional conflicts;
- showing the possible consequences and results of the manifestation of international and regional conflicts;
- consideration of the main methods and methods of researching modern international conflicts;

- formation of knowledge about the structure of international conflict;
- the ability to distinguish individual phases, stages and analyze the dynamics of an international conflict;
 - carry out classification and types of existing international and regional conflicts;
- describe the geography of modern international and regional conflicts; analyze the main problems of settlement and resolution of existing international conflicts;
- to study the experience of conducting international negotiations on the settlement of conflict situations;
- to understand the structure and goals of the international negotiation process and determine the tasks for mediation in the settlement of international disputes; to be able to predict the consequences of the negotiation process, etc.

V. Final Cotrol

The form of final control is a credit, which is set based on the results of the types of work that are provided for in the syllabus of the educational component. Tasks from these types of current control are evaluated in the range from 0 to 100 points. The student can additionally pass the topics he missed during the semester (for valid reasons) in consultation with the teacher, thus improving his result by exactly the amount of points provided for the missed topics. In the event that a student received less than 60 points, he makes a credit during the liquidation of academic debt. In this case, the points scored during the current assessment are cancelled. The maximum number of points during the liquidation of academic debt from credit is 100.
