# 8. INDIVIDUAL STUDENT'S TASK

At the beginning of studies, the student chooses a country, monitors its foreign policy during the academic semester, and keeps a file. After completing the course, students write an analytical note on events in one of the countries, and students exchange files. Assessment for file management is 10 points.

#### 9 EVALUATION POLICY

Attending lectures and seminars, the maximum number of permitted absences: 3. Rescheduling of practical classes in case of a valid reason (hospitalization, studying abroad, etc.). Performance of Individual task is on the basis of academic integrity. Zero tolerance for copying and plagiarism.

The discipline consists of three content modules. The final grade on a 100-point scale consists of the total number of points for:

- 1. current assessment on relevant topics (maximum 40 points);
- 2. module test papers (maximum 60 points).

For the answer during the seminar session, the distribution of points is as follows: 10-8 excellent; 7-5 – good; 4-2 – satisfactory; 1-0 is unsatisfactory.

In content module 1-6 seminar classes, assessment for each class is 10 points. In the content module, there are 2-5 seminar classes, the assessment for each class is 10 points. In the content module 3-8 seminar classes, the assessment for each class is 10 points. The overall total score for the current assessment at seminar classes is 30 points (arithmetic average). Students receive 10 points for INDZ.

#### **10.FINAL CONTROL**

The modules control involves the implementation of 3 MTP, each of which is valued at 20 points. The first modular control (forecasting) test is performed in the first lesson: based on the knowledge gained from the disciplines previously taught to the students, they make a forecast of the activity of the Ministry of Foreign Affairs of Ukraine for the next 4 months. Students are divided into teams. The results are drawn up on whatman sheets and presented to the group. The second modular control (theoretical) work involves checking the theoretical knowledge of the terms and concepts of foreign policy analysis and forecasting. The third modular test (analytical): students write an analytical note about the events in one of the countries, exchanging the dossier with other students.

The final control takes place in the form of an exam, for the completion of which a student can receive a maximum of 60 points. A student must take the exam if he scored less than 75 points during the semester, or if he does not agree with the points he scored. In this case, points for modular test papers are canceled, points for the current assessment remain. The total number of points for the course is 100. The grade for mastering the course is assigned according to the grading scale.
