III. DESCRIPTION OF THE EDUCATIONAL COMPONENT

1. Summary.

The educational component is designed to acquaint students with the essence and structure of the customs and tariff system of the state and the peculiarities of customs and tariff relations. The feasibility of studying the educational component is determined by the need to understand the system of customs and tariff regulation of foreign economic activity. Because the acquired knowledge and skills can be used in practical activities and are necessary for the formation of a highly qualified specialist in the field of international economic relations and international business in particular.

2. Prerequisites: knowledge of the basics of the theory of international economic relations, micro and macroeconomic basics of international business, mathematics and statistics for economists, international economic integration.

Post-requisites: International Trade, Economics of the Company, Accounting and Analysis of Foreign Economic Activity, Regulation and Security of MiB, etc.

3. Purpose and tasks of the educational component.

The general purpose of the educational component is to provide generalized information on the modern foundations of the functioning of the country's customs and tariff system, as well as the evolution of customs business on the territory of Ukraine; the functioning mechanism of the country's tariff system; assessment of the consequences of the functioning of the tariff regulation mechanism; features of the customs taxation system; customs control as a component of customs policy; characteristics of the customs clearance system and the system of customs regimes; integration of the customs system of Ukraine into the world economic system. However, the educational component is also aimed at developing certain skills, such as analytical skills, critical thinking, integration of knowledge from different topics, awareness and openness to current initiatives in the economy.

4. Learning outcomes (competencies).

Control methods*: DS – discussion, DB – debate, T – tests, TR – training, RZ / K – solving problems / cases, INDS / IRS – individual task / individual work of the applicant for education, RMG – work in small groups, MKR / KR – modular test paper / test, P – abstract, as well as analytical note, analytical essay, analysis of the work, etc.

6. INDS.

Conducting and presenting the results of the study: "Achieving European standards and integrating Ukrainian customs into the EU customs space".

Students can independently choose a topic for completing the INDS within the general topic. However, the selected topics should not be repeated.

IV. ASSESSMENT POLICY

Attending seminars is a mandatory component of the assessment, for which points are awarded. Missed seminars can be worked out as an individual assignments if there is a reasonable excuse for the missing class. Students who miss seminars without a weighty reason get lower points.

Also, the student has the right to the recognition of learning outcomes obtained in formal, non-formal and/or informal education (<u>https://cutt.ly/9wPgvTK1</u>).

Students must adhere to the principles of academic integrity.

All forms of cheating – on the credit, homework, assignments, control work – are unacceptable.

Also, one of the greatest violations of the standards of academic life is plagiarism.

V. FINAL CONTROL

For each topic of the content module, that are discussed/presented at the seminars the student can get some points as it is given in the table above.

In case of *exam* the maximum number of points for studying the course is 100, including:

- up to 40 points for participation in discussions (seminars);

- up to 60 points for the final module control (exam).

A student who scores more than 75 points before the exam can agree to credit these points as the final grade for the course (without passing the exam). Students who score less than 75 points or want to improve their final grade for the course take the exam at the time specified in the schedule of the test and examination session. The exam is conducted in oral form. The required minimum for successful completion of the course is 60 points (see the Regulations on the current and final assessment of knowledge at Lesya Ukrainka VNU – https://vnu.edu.ua/sites/default/files/2023-09/2023_Polozh_pro_otzin.pdf).

- 15.Determination of the actual and optimal level of the customs tariff.
