

Collect information about the city, district centre, village, settlement, which will help the candidate for deputies to make an election campaign plan in the relevant territorial formation.

## IV. EVALUATION POLICY

Attending lectures and seminars is compulsory, the maximum number of allowed absences: 3. Rescheduling of practical classes in case of a good reason (hospitalization, studying abroad, etc.). Implementation of IRP is on the basis of academic integrity. Zero tolerance for copying and plagiarism.

The discipline consists of three content modules and its study involves the completion of the IRP. The final grade on a 100-point scale consists of the total number of points for:

- 1) current assessment on relevant topics (maximum 40 points);
- 2) module test papers (maximum 60 points).

For the answer during the seminar session, the distribution of points is as follows: 12-10 excellent; 9-7 – good; 6-4 – satisfactory; 3-0 is unsatisfactory.

In the content module 1 – 5 practical lessons, the assessment for the lesson is 12 points (final – arithmetic mean). In the content module, there are 2 – 4 lessons, the grade for the lesson is 12 points (final - arithmetic mean). In content module 3, there are 3 lessons, the grade for the lesson is 12 points (final - arithmetic mean). The overall total grade for the lesson is 24 points (total). Laboratory works (10) are also evaluated in 12 points. An individual research task involves a creative approach, the identification of systematic knowledge and additional training of the student. It is estimated at 16 points. The modules test control involves the implementation of 3 MTP, each of which is valued at 20 points.

## V.FINAL CONTROL

According to the syllabus of AC, the student completes three module test papers, each of which is valued at 20 points, the total is 60 points. The performance of works requires the student to show the acquired theoretical knowledge and approach the projects creatively and creatively.

1 MTP – “Read the politician”: students watch videos of a choice of pairs of politicians and make a comparative analysis of verbal and non-verbal communication. Pairs: M. Saakashvili and P. Klimkin; D. Trump and A. Merkel; V. Putin and B. Jones; E. Macron and S. Jinping; Kim Jong Un and R. Erdogan.

2 MTP: Essay on The work of the special services of the USA and the Russian Federation. Students watch two films Red Sparrow [https://kinanema.net/load/filmi\\_ukrajinskoju/chervonij\\_gorobec/120-1-0-12837](https://kinanema.net/load/filmi_ukrajinskoju/chervonij_gorobec/120-1-0-12837) and Bridge of Spies [https://kinanema.net/load/filmi\\_ukrajinskoju/mist\\_shpiguniv\\_2015/120-1-0-6351](https://kinanema.net/load/filmi_ukrajinskoju/mist_shpiguniv_2015/120-1-0-6351) and make a comparative analysis of the activities of intelligence, diplomacy and special services in the form of an essay

3 MTP: to compile a forecast tree of information security problems in Ukraine based on the video of the round table Information Security at the Modern Stage (February 27, 2020), organized by the NGO “Communication and Content Security Center”; NGO “Organization for Consumer Protection in Cyberspace” with the assistance of Ukrinform – <https://www.youtube.com/watch?v=4N70Rw6TXbs>.

Final control takes place in the form of an exam. The exam is set automatically on the condition that the student has completed all types of educational work defined by the program of the academic discipline and received at least 75 points. In the event of an unsatisfactory final grade, or if a student wishes to increase the rating, the student can gain points by redoing a certain type of work. The total number of points for the course is 100. The grade for mastering the course is assigned according to the grading scale.
