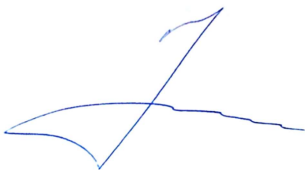

## 3. DESCRIPTION OF THE ACADEMIC COMPONENT

<b>A course abstract</b>	Educational practice provides for the improvement of the professional and practical training of applicants and ensures that they acquire the specified competencies using the material and technical base. The practice of information and analytical activities in international relations involves the organization and conduct of information and analytical work in the field of international relations, the collection of information and its analytical use, the analysis of individual problems in the field of international relations, the specifics of analytics and political forecasting, the features of information and analytical support of state bodies authorities, analytical and synthetic processing of documents (ASOD), methodological aspects of information and analytical work.

## 6. TYPES (FORMS) OF INDIVIDUAL TASKS

Completion of individual tasks by students is an important stage in solving the main tasks of educational practice. An individual task is developed by the head of practice individually for each student. The content of the individual assignment should take into account current problems in the field of international information and public communications and at the same time meet the goals and objectives of the educational process. The implementation of individual tasks involves the allocation of two stages:

1. General assessment of the chosen direction of research. So, within this stage, the following steps should be taken:

- drawing up a general idea about the selected research topic;
- searching for information from various sources on the chosen topic, recording it for further processing and analysis;
- definition of key factors, priorities and tasks.

2. Preparation of a report based on the collected information. The report should contain both collected empirical information, data, and synthesized conclusions. The volume of the report should be 10-15 pages. Structurally, the report should consist of an introductory part, main provisions, and conclusions. In the introductory part (introduction) it is necessary to display general information. The conclusions should contain a brief summary of the material, the definition of trends. After the conclusions, a list of used sources and literature is placed. Thus, within the scope of individual tasks, the student of higher education should critically evaluate the collected information on the chosen topic and prepare a report in the process of analytical processing of empirical material.

## 7. APPROXIMATE LIST OF INDIVIDUAL TASKS FOR STUDENTS

### Task 1

Students carry out «Internet analytics» research based on the sites of 3 (three to choose from) government bodies of one of the countries of the world (to choose from). The following services are used to perform the task:

- Google trend (<http://www.google.com/trends>) – allows you to get data on the topic on the Internet from 2004 to the present day of various countries and regions;
- Google insights for search ([www.google.com/insights/search/?hl=ru](http://www.google.com/insights/search/?hl=ru)) – Google's search statistics allow you to compare different search queries to discover the most popular ones. Comparisons can be made over certain periods of time, across countries and regions, as well as in different thematic categories.
- Alexa (<http://www.alexa.com/>) – a subsidiary of Amazon.com, known for its site, which collects statistics about site visits. Alexa collects information directly from users who have installed the Alexa Toolbar, on the basis of which statistics on site visits and lists of interconnected links are formed. The headquarters of the company is located in California, USA.
- Internet statistics service «HIT.UA» (<http://hit.ua/>) - allows you to evaluate the ratings of sites, their audience.

The research period is one year. The research is conducted according to the following criteria:

- analysis of the number of appeals from citizens to authorities;
- analysis of appeals by demographic indicators (gender, age, education, etc.);
- analysis of appeals by topic (what information do citizens want to receive from authorities);
- geography of appeals (are there appeals from other countries, appeals by regions, regions, federal entities, etc.);
- the structure of the websites of the state authorities of the selected country;
- dynamics of changes on sites and portals;
- from which portals (Google, Alexa, etc.) most people access the websites of government bodies;
- analysis of news topics on the websites of the authorities of the selected country.

Thus, in the conclusion, it should be noted what role the websites of the authorities of a certain country play in receiving a response to citizens' appeals, compare the relevance of the request and the information on the website. Assess the importance of the site to the public.

To carry out an analysis of the tasks and functions of the information and analytical structures of the following authorities, local self-governments of Ukraine and information and analytical centers based on these sites:

- Ukrainian Center for Economic and Political Research named after Oleksandr Razumkov,
- Committee of Voters of Ukraine (KVV),
- Laboratory of legislative initiatives,
- Ukrainian Independent Center for Political Research (UNICPR),
- International Center for Prospective Studies (ICPS),
- Center for Political and Legal Reforms,
- «Democratic Initiatives» Foundation,
- Kyiv Institute of Management Problems named after Gorshenin.

## **8. EVALUATION OF PRACTICE RESULTS**

Applicants must attend a briefing on the procedure for completing the internship, familiarize themselves with their duties and choose an individual task.

Students complete an individual task independently, adhering to the policy of academic integrity. The level of independence of the performed work is checked by the head of the practice.

Students are required to complete individual tasks and prepare a report by the time of the internship defense.

The report of students of higher education on practice is accepted by the head of practice from the department after the end of the practice period.

Evaluation of the results of students' practice is carried out on a 100-point scale with mandatory transfer of points to the institutional scale. The assessment for practice is included in the credit and examination information and the record book of the student of higher education under the signature of the head of practice from the department.

The final grade for practice is calculated as the average score based on the results of the individual task.

A student who did not complete practice tasks for good reasons may be granted the right to repeat practice during the next academic year according to an individual schedule. A student who received a negative grade on practice for the second time is expelled from the university.

The system for evaluating students' knowledge and the report on educational practice is shown in Table 1.

The transfer of the points of the final assessment into the traditional national assessment is carried out according to the following scale:

«Excellent» (from 90 to 100 points) - the content and design of the report meet the standards. The student's characteristics are positive. The student gave complete and accurate answers to all the questions of the internship supervisor regarding the internship program and the completed individual work.

«Very good» (from 82 to 89 points) - there are some comments regarding the content and design of the report. The student's characteristics are positive. In general, the student generally has solid knowledge regarding the goals of practice and its implementation.

«Good» (from 75 to 81 points) - there are minor comments regarding the content and design of the report. The student's characteristics are positive. The student made some inaccuracies in the answers to the internship manager's questions about the internship, although he generally has solid knowledge.

«Satisfactory» (from 67 to 74 points) - careless preparation of the practice report. The vast majority of practice questions and tasks are covered in the report, but there are some calculation and logical errors. The characteristics of the student in general are positive. Answering the questions of the head of practice, the student felt insecure, got lost, made mistakes, and showed superficial knowledge.

«Sufficient» (from 60 to 66 points) - incorrect design of the practice report. Some issues of practice are highlighted in the report, but there are some logical and analytical errors. The characteristics of the student in general are positive. Answering the questions of the head of practice, the student felt insecure, got lost, made mistakes, and showed superficial knowledge.

«Unsatisfactory» (from 1 to 59 points) - this grade is assigned to the student if the report does not cover all the issues or the work was not prepared independently. The characteristics of the student in relation to practice and work discipline are negative. The student could not give satisfactory answers to the questions of the practice leader.
