## III. DESCRIPTION OF THE ACADEMIC COMPONENT

### 1. A Course abstract

«Foreign policy of Ukraine and national interests» is an important and necessary AC, which students of the Faculty of International Relations in the second year study. Ukraine occupies a favourable geopolitical position between the West and the East. However, a favourable geopolitical position does not automatically ensure benefits for a country. This should be done by the country's foreign policy. The basic requirement in implementing Ukraine's foreign policy is to provide the country's national interests as fully and efficiently as possible.

The national interests of Ukraine in the field of international relations comprise three main groups: - strategic and geopolitical interests related to ensuring Ukraine's national security and protecting its political independence; - economic interests related to the integration of Ukraine's economy into the global economy; - regional, subregional, local interests related to the provision of various specific needs of the internal development of Ukraine.

## **2. Goal and tasks of the academic component**

*The goal is:* to research the leading conceptual approaches of the foreign policy of Ukraine, their characteristic features and foreign policy priorities during the history of formation since independence, with a detailed consideration of the specifics of the content and principles evolution after the end of the «Cold War»: in the 1990s – at the beginning of the 21st century. The AC is aimed at forming an idea about: the foreign policy course of the Ukrainian state and its role in international relations at the end of the 20th – the beginning of the 21st century; participation in integration processes; clarifying the peculiarities of Kyiv's foreign policy activity in the post-bipolar era, the main approaches to solving global problems, forming a new system of international relations, ensuring regional and international security; development of bilateral interstate relations; expanding participation in European regional cooperation; cooperation within integration associations; membership in the UN and other universal international organizations.

*The task is* to form in the applicants a holistic idea of the direction and content of the foreign policy of the Ukrainian state at various stages of its development.

## V. FINAL CONTROL
