Why it is interesting / should be studied?	climate diplomacy has become a new promising direction of international cooperation between states and non-governmental organizations, the main goal of which is to fight the global problem of climate change at all levels and directions. States remain one of the main actors in climate diplomacy, although each of them has different importance and different strategies for climate negotiations. At the same time, non-state actors play an

	important role in the formation and implementation of policy on topical issues: global banks, regional, international and supranational organizations, non- governmental organizations and even sub-national state bodies. It is among them that there are more and more active participants in the architecture of climate change, and therefore, subjects of climate diplomacy. Participants of civil society also contributed to the multilateral solution of global problems, including the problem of climate change, and therefore they belong to the subjects of modern climate diplomacy.
What you can learn (results)	solving climate change problems in a political sense; analysis of the climate diplomacy features, which result from the changes that have taken place in the world of modern diplomacy, in particular, the increase in the number of participants in world affairs and the types of international relations subjects; change in the levels of diplomacy and diplomatic activity involvement – from local, domestic, to bilateral, regional and global; expansion of the scope and volume of diplomacy objects; change of apparatus and mechanisms of foreign relations and diplomats; change of regimes, types and techniques of diplomacy.
